**Unconditional Waiver and Release of Liability (“Waiver”)**

The undersigned Participant represents, and as a condition of being allowed to participate in the tour arranged by Art House Lectures & Tours, Inc., a Michigan corporation (herein “Art House”) described as **Spain Tour** to be conducted on or about **February 2018** (for purposes hereof the “Tour”) and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, acknowledges and agrees as follows (for purposes hereof the terms of this document are herein referred to as the “Waiver”):

1. Understanding of Risks. The Participant represents that he/she is fit and capable of participating in the Tour without accommodations. The Participant has been advised that there are risks inherent in some tours, particularly when traveling outside of the United States in undeveloped or remote areas, and that for tours outside the United States medical services may be unavailable, limited or not to the standards they would otherwise expect. The Participant is responsible for their medical care or evacuation should that be required, and has been advised to consider if their medical insurance is sufficient and, if not, to obtain supplemental coverage. Prescribed medications should be left in the original container identifying it as being prescribed for the Participant and kept in the Participant’s possession (e.g. do not pack in checked baggage or leave in your hotel room if you will need it during the day).

2. Art House is Not a Service Provider. Art House has acted only in the capacity of an independent agent in making arrangements for transportation, accommodations, local tours, meals, and other services and will not be the direct provider of these services on the Tour. Art House assumes no liability for any act or default of any service provider. Art House is under no obligation to seek any refund or reduction in charges for any services that are cancelled, delayed or defective. Art House may make such changes in the tour as it determines appropriate due to any default of any service provider, changes in conditions or circumstances or otherwise.

3. Art House Has Made No Representations or Warranties. Art House has not made any representations or warranties in regard to the services that are provided by others. The descriptions of such services are not representations or warranties of Art House.

4. Waiver and Release of Claims. Each undersigned Participant for him/herself and his/her successors, assigns, heirs and personal representatives, and for any and all persons claiming for him/her or on his/her behalf and their successors, assigns, heirs and personal representatives, (for purposes hereof individually and collectively, the “Tour Parties”), expressly waive, release, acquit, and forever discharge Art House, and its shareholders, directors, officers, agents, employees, representatives and affiliates, and each of their successors, assigns, heirs and personal representatives, (for purposes hereof individually and collectively, the “Art House Parties”) from any and all claims, demands, actions, causes of action, suits, debts, dues, sums of money, accounts, contracts, agreements, promises, damages, injuries, liabilities, and controversies whatsoever, in law or in equity, which the Tour Parties now have, have had, or may have, or which now or in the future could be asserted by the Tour Parties against the Art House Parties, or any one of them by reason of, or arising out of, any matter, act, transaction, occurrence, or omission arising out of participation in the Tour or any direct or indirect event or occurrences in connection therewith occurring before, during and/or after the Tour, including, but not limited to claims for death, personal injury, property damage, or loss.

It is the intention and agreement of the Tour Parties to absolutely and forever unconditionally release, acquit, and discharge the Art House Parties from any and all liabilities and obligations of every conceivable kind, character and nature, whether absolute or contingent, and whether known or unknown, in connection with the participation by the Tour Parties in the Tour.

5. Covenant Not to Sue and Agreement to Hold Harmless. The Tour Parties covenant not to sue the Art House Parties in connection with any claims that are the subject of the foregoing waiver and release of claims, and the Tour Parties agree to hold harmless and defend the Art House Parties from all liability, cost or expense (including actual attorneys fees) incurred in connection with any such claims.

6. Rights Retained Against Service Providers. Nothing in this Waiver shall restrict the ability of the Tour Parties to bring an action against a direct provider of products or services.

7. Jurisdiction and Waiver of Jury Trial. This Waiver is made in the State of Michigan and is to be governed by, and construed under, the laws of the State of Michigan. Any claim against the Art House Parties shall be made in the Wayne County Circuit Court in Detroit, Michigan. The undersigned EXPRESSLY WAIVES THE RIGHT TO A JURY TRIAL.

8. Entire Agreement. This Waiver contains the entire agreement in regards to the subject matter hereof, and supersedes any prior understanding, agreement, or representation, written or oral regarding the subject matter of this Waiver.

9. Partial Invalidity. This Waiver shall be enforced to the greatest extent permitted by law. The provisions of this Waiver are severable, and the invalidity of any portion of this Waiver shall not affect the remaining portions of this Waiver.

10. Limitations on Claims. Any claims that may be brought against the Art House Parties shall be made (i.e., the complaint filed and the summons and complaint served on the Art House Parties) within one hundred eighty (180) days after the last day of the Tour. Any claims made after that date shall be forever barred.

11. Successors and Assigns. This Settlement Agreement and Release shall be binding on and inure to the benefit of the parties and their respective, heirs, successors and assigns.

12. Free Act and Deed. The undersigned Participant(s) has fully read this Waiver, understands its contents, and is signing this Waiver as his/her own free act and deed, without any coercion on the part of anyone, after relying on the advice of his/her own independent counsel or having had the opportunity to have sought the advice of his/her independent counsel.

I hereby authorize Art House to use my name and likeness during the recording or photography of any tour; to be used solely by Art House. I waive any rights of compensation or ownership thereto.
